**AIRPORT**

Philadelphia International Airport is 30 minutes from the Club. Baltimore Airport is 90 minutes away.

**DIRECTIONS**

To DuPont Country Club (302) 421-1753 (Golf Shop). Note, route 141 has been rerouted recently. Old maps and navigator systems will not reflect the current routing near the club. From Philadelphia Airport – Take 1-95 south to route 202 north. \*Follow 141 traffic signs (immediate right exit, stay in left hand lane.) Turn left on Children's Drive (second light). At first light turn right onto Rockland Rd. Club is on right. From I-95 north – take exit for 202 North (Concord Pike) and follow directions from \* above. From NJ Turnpike and I-295 – Cross Delaware Memorial Bridge. Go north on I-95 and follow directions above. From 202 southbound – Take route 141 exit. Turn right onto 141. Turn left on Children's Drive, then right onto Rockland Rd. Club is on the right.

**PRIVATE HOUSING**

A limited amount of housing will be available. Contingent upon receipt of the private housing request (on entry form) and acceptance to the Championship, a housing application will be sent. Spaces will be granted on a first-come, first served basis.

## ENTRY REQUIREMENTS

The Championship is open to female amateur golfers, with a certified handicap index of 11.5 or less and who belong to a WEGA Member Club (or have school affiliation) that has paid dues for 2008. Clubs and schools in the following states are eligible to join the Association: Connecticut, Delaware, Florida, Georgia, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, North Carolina, Pennsylvania, Rhode Island, South Carolina, Vermont, Virginia, and the District of Columbia.

The contestant's club or school must be a member of the Women's Eastern Golf Association. THE \$30.00 NON-REFUNDABLE DUES FOR 2008 MUST BE PAID BEFORE THE ENTRY DEADLINE.

(Contestant may remit dues for her club).

The field will be limited to the eighty (80) applicants with the lowest handicap index. **A current GHIN or IGN card must accompany the entry. Entry must be filled out in its entirety, signed and postmarked on or before May 9th.** Post entries will be accepted if the field is not full. Notification of acceptance will be mailed by **May 16th.** Other applicants will be placed on a waiting list in order of handicap index, and vacancies will be offered in that order. Waiting list applicants will be notified of their status. A signature of parent or guardian will be required for applicants under 18 years of age.

## REGISTRATION

Contestants **MUST** register on Monday, June 9th from 8:00 a.m. - 2:00 p.m. at DuPont Country Club or notify the Committee of late arrival. Failure to do so will result in forfeiture of place. DuPont Country Club Golf Shop: **302-421-1753.**

## PRACTICE ROUND

The course will be open to contestants from 8:00 a.m. to 2:00 p.m., Monday, June 9th. Call Golf Shop for starting time after June 1st. **302-421-1753.**

## PRIZES

Prizes are awarded to the Champion and the Runner Up and the 8 Low Gross Finishers.

The OSGOOD SHIELD award is given for team stroke play and is competed for concurrently with the Championship. Teams must have a minimum of five (5) players and will be drawn. Posting 5 gross scores daily, the team having the lowest 3 day aggregate score wins the Shield. Prizes will be awarded to the winning team.

## CHAMPIONSHIP FEES

A Contestant will be required to pay **both** the **Entry Fee** and the **Host Club Fee** and include the checks (2) with her entry form.

**Entry Fee: \$90.00** Make check payable to **WEGA.**  
**HOST CLUB FEE is \$100.00** payable to **DuPont Country Club.**

This fee includes range balls and cart fee for four days. Club storage is available for \$10 per day payable at registration. A player may carry her own bag but the full fee still applies. No caddies permitted.

*Total refund for cancellations up to June 2nd. **Entry Fee** will **NOT** be refunded after June 2nd. **Host Club Fee** will **NOT** be refunded after June 6th.*
